## **Information Factors:**

During the evening hours of December 21, 2024, Belleville Police Service officers were dispatched to the front lobby of the station for a domestic assault complaint.

Responding to the victim's statement, an officer formed reasonable grounds to charge a male with multiple serious offenses, including assault, assault by choking, mischief, and uttering threats.

Shortly before 1 a.m. on December 22, officers attended the suspect's residence in the city's east end to execute the arrest.

Upon arrival, the suspect refused to engage, barricaded himself inside, and sent threatening messages indicating he was armed and intended to harm himself if police

entered. Officers observed him with an edged weapon, which he repeatedly held to his throat, making clear his intentions.

Recognizing the high-risk nature of the situation, the patrol Sergeant assumed initial command and coordinated containment and negotiation efforts.

With the involvement of Incident Commander and Tactical Commander, additional resources were deployed, including the Emergency Response Team, K9 Unit, Crisis Negotiators, Belleville Fire, EMS, and Criminal Investigations.

Despite extreme cold temperatures of -18°C and a prolonged standoff lasting over four hours, the negotiation team de-escalated the situation. At 4:14 a.m., the suspect surrendered and was taken into custody without injury to himself, officers, or the public.

This commendation acknowledges the extraordinary teamwork, discipline, and perseverance displayed by all personnel involved.

From the response to the initial call to the seamless coordination of specialty units, this incident is a testament to the professionalism of the officers involved.

## Information Factors:

In early 2024, as in previous years, the Operations Division focused on developing proactive strategies and initiatives in line with the current areas of focus and objectives of the Belleville Police Service (BPS) Strategic Safety Plan 2022-2024.

All four platoons and the Traffic Safety Unit developed plans and submitted them for review. In December 2024, all outcomes were forwarded to Deputy Chief Meeks who was Inspector of Operations at the time of submission.

Projects focused on several different areas of concern and included processing and addressing road safety concerns, addressing crime through effective call response,

investigations, enforcement and police visibility, and strengthening community engagement to crime prevention through awareness and education.

One platoon developed a project entitled Project Triple P for Partners, Proactive and Patrol with a mission to effectively deploy, monitor and track proactive patrols in areas of the city that were encountering repetitive property crime as well as mischief, trespassing, and drug usage. Additionally, the platoon identified the need to build and maintain relationships and confidence with all community partners in particular business and property owners.

With the utilization of internal communications and requests for "extra patrols" as well as crime analysis data, the platoon strategically deployed members to conduct proactive patrols and document results. Additionally, members liaised with business and property owners that may be interested in proactive patrols and would consider an "Agent Status" program. Agent status refers to the police being given authority to act on behalf of a property owner with respect to trespassing on private property and authorities given to property owners under the TTPA.

In a short period of time, over 110 property checks were conducted at addresses requesting assistance, 12 individuals were moved along, one arrest was made and 10 new agent status forms were submitted to BPS with a continued commitment to educate more businesses and property owners on this initiative.

Other areas focused on were employee engagement and training with platoon members receiving immediate debriefs and training on case law decisions, cell phone extractions, searching, further de-escalation training and high-risk incident debriefs and training involving firearms, robberies and edged weapons. The utilization of actual body worn camera (BWC) footage of our own members was instrumental in providing accurate and effective training.

Another area of focus for the Operations Division was proactive compliance checks for offenders in our communities on criminal court release orders as well as effecting arrests on outstanding warrants for individuals in our community. This was done with the ultimate goal of community safety and crime prevention at the forefront. Door knocks were conducted for offenders on release conditions or on parole in our community and as a result, 68 arrests for individuals wanted on warrants occurred, and 10 arrest warrants were issued for breaches of release orders, probation, or conditional sentences.



Moreover, numerous offenders were located and found to be complying with their conditions.

In additional to responding to over <u>27,460</u> calls for service in 2024, this report highlights the additional ways our members focused on strategic safety plan objectives and proactively addressed areas of concern in our community while also enhancing internal communication and training.

## **Financial Implication:**

The province has provided funding for all of the new call handling system mandated by the Canadian Radio-television and Telecommunications Commission (CRTC) at a cost of \$418,166.39 plus provided additional funding for fiber connectivity, furniture, professional services and other IT systems to support the transition.

## **Information Factors:**

The Belleville Police Service is bringing a new emergency call-handling system called Next Generation 911 (NG-911) to Belleville.

The new system will bring innovative new technology to replace Ontario's 30-year-old 911 voice-based infrastructure once it is fully operational. The first steps are underway with the focus on installing the necessary infrastructure and staff training.



Partners with the Community

911 callers will have a new experience when connecting with emergency services once all the pieces are in place. The initial phase will allow communicators to receive and respond to texts with future phases allowing photos and videos to be shared.

The province has provided funding for all of the new call handling system mandated by the Canadian Radio-television and Telecommunications Commission (CRTC) at a cost of \$418,166.39 plus provided additional funding for fiber connectivity, furniture, professional services and other IT systems to support the transition.

Police control room operators will be able to take advantage of the latest technology available when assessing an emergency and dispatching the appropriate response once the NG911 infrastructure is up and running.

Other benefits of the modernized system will include improved 911 caller location information, improved responder safety and awareness, and improved assistance for the hearing-impaired community.

The Belleville Police Service had selected Solacom Guardian as its NG911 call handling solution. Solacom has been successful in winning several opportunities across mid to large police services across Canada. Working closely with Bell 911 Services, Belleville is slated to receive its equipment in early December, and commence installation and testing in January 2025.

At the same time, Belleville Police Services will be bringing online a fully redundant secondary dispatch site, in the event of a significant failure at our primary headquarters.

The CRTC requirement means that all provinces, municipalities and their Primary Public Safety Answering Point (PPSAP) providers need to meet the new NG-911 standards no later than March 4, 2025, at which time the legacy systems will be disconnected.

Belleville Police Service provides call answering and dispatch services for the City of Belleville, and the Town of Deep River.
